



## Conference Publishing Agreement

---

In accepting to review the author's full paper, AMPS commits to publishing the conference papers in either its online conference proceedings or as extended articles and chapters in the *Architecture\_MPS* journal or associated book publications.

Publication will subject to standard double-blind peer review processes.

Submission of a full paper for review implies that the work has not been published before (except in the form of an abstract or as part of an unpublished lecture, or thesis) and that it is not under consideration for publication elsewhere. Accordingly authors agree to AMPS being the publisher of the paper in either its 3000 word conference format or subsequent article/chapter length versions of 5000-7000 words. Papers cannot subsequently be offered to third party publishers without prior agreement with AMPS.

If accepted for publication, the author agrees to undertake any revisions indicated in the peer review process. If authors are unable or unwilling to make revisions after acceptance of the paper, the editors reserve the right to make any reasonable editorial changes seen as necessary.

Copyright of images is the responsibility of individual authors and in submitting the full papers for review and subsequent publication, authors accept responsibility for sourcing any third party agreements that may be necessary.

Once published by AMPS all papers are subject to the AMPS Open Access policy which means that content is available without charge to the user or his/her institution for individual research purposes. Users republishing materials must fully cite and reference the source of the material accessed and used under this agreement as described below. Copyright of the paper remains with the author.

### **Conference presentation:**

Surname, first name. "Title of the presentation." Presentation at the AMPS conference [insert name of conference], host university, city, country, date.

Example:

Brown, James. "The Global Local." Presentation at the AMPS conference *Digital Cultural Ecology and the Medium-Sized City*, University of the West Of England, Bristol, England, April 1-3, 2016.

### **Article in the AMPS journal:**

Author surname, Author first name. "Title of the article." *Architecture\_MPS* volume number, issue number (year): page range. Date accessed. Web link.

Example:

Cairns, Graham. "Architecture as Political Image". *Architecture\_MPS* 1, no.1 (2012): 1-13. Accessed March 30, 2016.
